## General Sales Conditions

### To Book your stay

When you book your holiday, you will have to pay a 25% first confirmation payment of the total amount of your stay as well as the file fees that aren't refundable. When we receive your first payment, the campsite will send a booking confirmation which you will have to present at the campsite the day of arrival. The balance can be paid 30 days before the arrival. Any booking or file modification, must be notified by letter.

### Our prices include

Entry to the aquatic center, water consumption, electricity, necessary equipment for the number of people stipulated in the price list (except additional people), cleaning at the arrival and access to free activities.

Beware, before and after the summer period, some accommodations or activities can be closed.

### Our prices do not include

Additional car, additional tent, additional person, daily visitor, cancellation guarantee as well as the file fees.

Tourist tax is to be paid on arrival which may vary depending on the town.

The sheets, bathroom linen and baby kit can be hired at the campsite.

Housecleaning at the end of stay for the apartments, mobile homes and cottages which must be cleaned, otherwise we asked for a compensation of 90€.

The contractual supplement for the animals (if accepted, please consult the price list).

The deposit of 200€ for the mobile homes and cottages, which will be received at the arrival will be returned on departure, only if nothing needs to be fixed, replaced, housecleaning or anything else. In that case the cost will be deducted from the deposit.

If you wish to leave before the scheduled inventory, the deposit will be returned to you within one month after your departure. On some campsites a deposit can be also required for a pitch rental or a swipe card.

### FranceLoc Brochure:

The booking to one of our stay implies the acceptance of our sales conditions. Taking into account the diversity of the accommodation range, it exist some differences in the configuration and decoration of the rentals.

We remind to you that any request for an orientation or specific location is an additional service and does not constitute a contractual guarantee.

In addition, the work undertaken by private individuals or public authorities and which could obstruct our customers on our campsites, cannot be held against us.

### After sale services

We cannot be held responsible for the unintentional events, case of force major, climate catastrophes which would disturb, stop or prevent the stay.

In case of problem in the rented cottage or the mobile home, you must formulate a complaint directly to the person in charge of the campsite.

Any complaint concerning the inventory, the state, the housekeeping of the rented cottage or the mobile home must be formulated under 48 hours.

Passed this time no complaint will be taken into consideration and you will be held responsible at the time of the departure for the possible damages or lacks.

Any observation or complaint concerning a stay must be notified at the head office of our company by registered mail/return receipt within to 1 month after the end of the stay. Our Quality control department will then deal with your complaint within 2 months following reception of your letter.

### Arrivals and departures

The accommodations are available from 4p.m up to 8p.m approximately 1 hour more or less depending on the campsite, the exact schedules will be mentioned in the booking contract which will be sent back to you once your booking is registered. Departure time is before 10a.m. Pitches are available from 2p.m and must be free before 12a.m. For an early arrival or departure, you must first advise the campsite

### Cancellation of the stay

Every cancellation must be notified by mail, fax or e-mail to the campsite.

You have 8 days (from the cancellation time) to send us your documentary evidence (medical or death certificate, or certificate of proficiency).

After the arrival date, you have 48h to tell us about any problem which would provoke the cancellation.

In the event of cancellation of the stay before the arrival, in the event of interruption of the stay, or postponed arrival and whatever the cause is, disease, accident or unforeseen event, the tenant will be held with the payment of the balance for the reservation and no refunding will be granted.

### Cancellation guarantee

This guarantee is optional and payable at the same time of the first confirmation payment in supplement of the hiring. The price is 24 € for a 7 day stay // 9 € for a short stay (from 2 to 6 nights).

If you subscribe to this guarantee, you are assured to be:

Refunded for your first confirmation payment, except for the file fees and cancellation guarantee. Refunded for the rent on "prorate temporis" basis, except file fees, cancellation guarantee and the cleaning expenses, if you must leave the rented accommodation before the planned date.

The guarantee works if the obstacle is caused by one of the following causes:

Death of the policy-holder.

A disease affecting the policy-holder, unknown at the signature of the contract, or accident or leasing agreement taking place after this signature.

The death, the disease or the accident which can affect, under the same conditions, the spouse of the policy-holder, his relatives or the spouse's one, his brothers and sisters as well as any other person usually living under her roof.

The death which can occur to the sons-in-law or sisters-in-law of the policy-holder.

An administrative summons, judiciary, military as well as a criminal jury trial.

If the obstacle is justified and due to a layoff or transfer of the policy holder or his spouse or the bankruptcy of the policy-holder's firm.

The guarantee, in the event of a disease or accident, must, to be effective, involve a medical prescription of hospitalisation or prohibition to

leave the room of the usual residence and to devote itself to any professional activity.

### Rules and regulations

Each campsite has its own rules and regulations displayed at the reception. As a customer of the campsite, this one is opposable to you.

Beware! Animals are prohibited in some of our campsites (they are anyhow never allowed around swimming pools, toilets and restoration points). The vaccine book can be asked at any time.

No extra installation (tents), vehicle or additional person is accepted on the pitches/accommodations without agreement of the campsite.

A bracelet has to be worn on the campsite. Swimming trunks are obligatory in the swimming pools (swimming shorts are prohibited).

On some campsites the barbecues can be prohibited. Please check with the campsite before your arrival.

Swimming pools entry is not allowed to visitors for security reasons.

(Except for the Domaine du Sagittaire where the visitor has to pay an entry fee to the aquatic center).

### Rental insurance

All tenants must insure themselves to an insurance company against the inherent risks to their occupation, which includes: thievery, loss or damage of their personal objects, as well as damages which they could make on the hired furniture, and also the damage which they could cause on the site in general, of their responsibility or by possible negligence.

The customers shall be able to prove everything at the first demand.

It is specified to the customer that all personal items, bags, objects, furniture, values, vehicles are not guaranteed against thievery, loss or degradation whatever the cause is. Parties agree that our company will never be threatened for this matter and that it is up to the tenant to subscribe to an insurance.

For the rent or the loan of bicycles, clients must be insured against rob, loss or damage. In the event of an accident, the campsite declines all responsibilities.
